- Social security card
- High school diploma or (GED)
- \$25 non-refundable administrative fee, payable with money order only to the **International Union of Operating Engineers Local 571 Training Fund**
- Physically capable of performing the duties of an Operating Engineer
- Pass a drug screen (DOT)
- All applicants must be able to proficiently understand, speak, and write in the English language
